The package of channels forming the basic service tier must include the compulsory transmission of three Doordarshan channels notified under Section 8 of the said Act and the genres of entertainment, news, sports, children's programmes and music that must be in English, Hindi and the regional language, depending on the availability of such channels in the areas afore-mentioned. # 28 May'03 COFI

gave a memorandum to Smt Sheila Dixit regarding implementation of CAS where some section of the media and consumer organisations are instigating the common masses against CAS on behalf of some foreign broadcasters.

# 29 May'03

Import duty on STBs reduced from 50.8% to 5% for a period upto 31st July, 2003.

# 30 May'03

Cable operators/MSO announce lucrative rental schemes for set top boxes.

# 31 May'03

The Maharashtra Union of Cable Operators and Control Room Owners held a daylong seminar on CAS in Pune. A resolution welcoming CAS and early implementation was passed.

### 11 Jun'03

#### 14 Jun'03

**COFI** sent a memorandum to the Chief Minister Smt Sheila Dixit requesting her for abolishing Entertainment Tax on Cable TV Services and not to levy any Sales Tax on Set-Top-Boxes.

## 18 Jun'03

Zee Turner launched a "Smart Sellers" training program for cable operators in Delhi, Mumbai, Kolkata and Chennai, to educate and inform them on the advantages of CAS.

## 19 Jun'03

**COFI** gave a memorandum to Smt Sheila Dixit to save the business of last mile operator who was the Pivot-Man of the cable Industry by introducing CAS.

#### 25 Jun'03

Excise duty comprising of countervailing duty of 16% and special additional duty of 4% waived off and basic customs duty on three main components used in STBs is reduced to 5%.

#### 27 Jun'03

A delegation of cable operators met Mr. Madanlal Khurana on 27 June, 2003 to coax him to rethink his strategy of opposing CAS. They requested Mr. Khurana not to make CAS a political issue. He does not pay any head.

## 30 Jun'03

Major broadcasters except Zee made the a-la-carte rates (maximum retail prices inclusive of distribution margins) available to the government. They also suggested 'dual feed' of channels (providing pay channels both with and without STBs) and 'twilight zone' the period during which pay channel telecast without STBs would not

be a cognisable offence, which the government is considering.

Cable operators meet media advisor in the I&B Ministry and PM confidante Sudheendra Kulkarni to discuss the issues of CAS.

### 1 Jul'03

Cable operators met I&B Minister and suggested giving all channels at Rs. 72 plus taxes to consumers till CAS is completely mandated. They rejected the 'dual feed' suggestion of the broadcasters, on technical and fiscal grounds. Dismiss the rates declared by broadcasters as non consumer friendly. Hint at hiking cable subscription fee at Rs. 530 p.m. if CAS is not implemented. Ask government to rethink on the FTA pricing of Rs. 72 which is much below the actual operational cost of Rs. 180 which they incur.

## 2 Jul'03

Major broadcasters met Sudheender Kulkarni (Media Advisor to the PM, Atal Bihari Vajpayee) to discuss various aspects of CAS, particularly the price factor.

## 4 Jul'03

The Center defers implementation of CAS to 1st September, 2003 on account of unavailability of sufficient Set Top Boxes. The implementation is to take place zone wise and to be completed by 1st December. From 1st August, till CAS is totally mandated consumers will have to pay only Rs. 72 plus taxes for all the channels. Zee TV announces **a-la-carte** price of its channels.

#### 5 Jul'03

While **COFI**, NCTA and CNA were satisfied with the government's decision and accepted the concessional rate in view of a smooth rollout of CAS, some Cable Operators United Forum protested the concessional rate for the initial period and instead said a sum of Rs. 180 would be charged for all the channels during the introductory period till CAS is fully implemented.

### 6 Jul'03

Broadcasters and cable operators differ on the duration of the concessional rate of Rs. 72 plus taxes for all channels. While a section of cable operators agreed to offer all channels for Rs. 72 plus taxes from August 1 to December 1, the broadcasters maintain the offer was restricted to a zone for the month before it was to be notified for CAS.

## 7 Jul'03

Unhappy with the broadcaster's reaction to the proposal of providing all channels at Rs. 72 plus taxes till CAS rollout, government says charging more than the said amount after 1st September in non-notified areas would be made punishable under the law.

# 9 Jul'03

A large section of cable operators, including distributors of leading MSOs met in New Delhi and rejected the Rs. 72 package either for the FTA under CAS, plus pay channels during the month long 'Honeymoon period', demanding instead the original price of Rs. 180 p.m. Any delay in the CAS implementation is threatened with blackouts.

# 10 Jul'03

CAS enabled in the first phase of its implementation. A cabinet meeting chaired by the Prime Minister endorses the plan for a phased CAS implementation. The Cabinet however held back an ordinance amending the Cable TV Act seeking more control over broadcasters, but sent it to the Law Ministry for a feedback.

### 10 Jul'03

The Central Government having been satisfied that it is necessary in public interest to do so, and in supersession of notification S.O,39(E), dated 14th January, 2003, hereby notifies the 1st day of March 2003 as the date within six months from which it shall be obligatory for every cable operator to transmit/retransmit programmes of every pay channel through an addressable system in the areas specified.

### 14 Jul'03

Delhi BJP Chief, Mr. Madan Lai Khurana meets PM, Atal Bihari Vajpayee demanding that CAS be implemented first in the other three metros and later in Delhi, only after it is successful there.

#### 15 Jul'03

In a joint statement the Indian broadcasters namely Aaj Tak, Sab TV, Sahara TV, Eenadu TV and Sun TV take a stand against the government's decision on December deadline for CAS rollout. Earlier on 11th July, they had demanded for a level playing field vis a vis foreign broadcasters on matters of taxation and legal obligations.

## 15 Jul'03

Cable operators oppose the government FTA rate of Rs. 72 plus taxes but demand Rs. 180 plus taxes. Broadcasters fail to declare rates as had been asked by the government, they refuse to have the honeymoon period for more than a month.

### 17 Jul'03

The I&B Minister Sh Ravi Shankar Prasad met the Prime Minister Sh Atal Bihar Bajpai to discuss the situation of CAS.

#### 21 Jul'03

- At a high level meeting held at the PM House, the government decided to stick to its plan of implementing CAS from September 1. The meeting was attended by senior Cabinet Ministers, Delhi BJP Chief Madan Lal Khurana, the I&B Minister Mr. Ravi Shankar Prasad, Mr. L K Advani, the law Minister Mr. Arun Jaitely and BJP leaders Mr. Venkajah Najdu and V K Malhotra.
- The Standing Committee on Information Technology under the Chairmanship of Mr. Somnath Chatterjee presented its report on CAS to the Hon'ble Speaker of the Lok Sabha. The report has criticized the government for setting an 'arbitrary' date for CAS implementation without looking into the factors required for it.

## 29 Jul'03

The Information and Broadcasting Minister set up an Implementation Committee for CAS on July 29th consisting of representatives from the cable and satellite industry. The committee was to look into:

- i) The availability of STBs, and their readiness for installation.
- ii) Modalities of installation including testing.
  - iii) Upgradation of the infrastructure and network for implementation of CAS and steps taken to protect consumers' interest.
  - iv) Availability of full information in respect of pricing of channels and the amount that cable TV subscribers will have to pay.

v) Any other issue that members of the Implementation Committee wish to raise. The panel was headed by Mr. Vijay Singh, Additional Secretary (Broadcasting) from the I&B Ministry. The committee members included: from the I&B Ministry Rakesh Mohan, Joint Secretary; Mohua Pal, Director I&B; from the broadcasters; Peter Mukherjea (Star); Kunal Dasgupta (Sony); Subhash Chandra (ZEE); G Krishnan (Aaj Tak) Raghav Bahl (CNBC-TV 18); CD Rao, Sun TV, from the MSOs; Rajiv Khattar (Siti Cable); Rajiv Vyas (Incable); - Jayaraman (Hathway); Dilip Sen (RPG Netcom) from the cable operators; Roop Sharma **COFI** Anil Parab and the representative(s) of concerned State Governments.

The Committee was to meet every week in order to monitor the progress of CAS. The committee would also interact with representatives of Consumer Protection Group and take steps to address their concerns.

### 29 Jul'03

The Ministry of Finance extends excise duty cut on imported set-top-boxes (STB) by two more months following the expiration of the current waiver on 31st July, 2003.

## Jul'03

Tamil Nadu cable operator association requested I&B Ministry to implement CAS either from July 1st or August 1st as cable subscription is collected by 1st of every month.

#### Jul'03

A suggestion of "Dual Feeds" twilight zone to the consumer came up by the Broadcaster.

#### Jul'03

Smt. Sheila Dixit - Chief Minister of Delhi, says that she is totally confused about CAS though activity about CAS is going on for last 3 years.

## 5 Aug'03

The first meeting of the implementation committee held:

- 1) The Additional Secretary to the I & B Ministry confirms implementation of CAS by  $1^{\rm st}$  September. He emphasized on the broadcasters to declare the MRPs of their pay channels along with the margins and incentives payable to the MSOs and the Cable operators.
- 2) Broadcasters submitted their inability to offer their pay channels within the FTA rate for the month of August. They preferred to declare the wholesale rates of their pay channels and mentioned that tiers should be prepared by the Local cable operators. They also desired that the government should ensure that 'content' is not denied to any one, subject to the business agreement entered into.

## 14 Aug'03

The second meeting of the implementation committee held:

The meeting was very optimistic resolutions like a timely implementation of CAS, no backtracking including inviting the MSOs in areas where the LCOs are not prepared or non co-operative and to ensure no hike in rates in August. However there was not much development of the following unresolved issues.

- a) Pay Channels rates. c) Incentive schemes for pay channels.
- b) Revenue sharing agreements, d) Platform sharing among broadcasters.

## 24 Aug'03

All Orissa Cable TV Owners Association (AOCTOA) organised a one-day workshop of CAS even though Orissa is not notified area.

# 25 Aug'03

After a high level meeting it was announced by the I&B Minister that CAS would not be implemented in Delhi till the assembly elections were over as it was becoming "an object of political hostility." The other three metros would however proceed as per schedule and implement CAS by 1st September.

# 28 Aug'03

- •The Madras High Court admitted a public interest litigation challenging the implementation of CAS in Chennai from September 1. Justice K Govindrajan, who admitted the petition from K. Surendra Kumar of T Nagar, ordered notice to the Union Ministry for I&B, Hathway Communications Pvt. Ltd. and Sumangali Cable Vision, asking them to file their reply on the petition.
- Cable Network Association moves the Delhi High Court seeking implementation of CAS in Delhi from September 1 as is being done in the other three metro cities.
- West Bengal Chief Minister, **Mr. Buddhadev Bhattacharya**, requested the Centre to defer the introduction of CAS in Kolkata and suggested the formation of committee to go into the ground level problems before starting the system.

# 29 Aug'03

Notification issued by the Central Government, deferring implementation of CAS indefinitely in respect of specified area in Delhi.

# Aug'03

The representatives from the Federal Communications Commission (FCC), the regulatory body in the US, came calling on officials of the Information and Broadcasting ministry to understand the ongoing debate on CAS.

## Aug'03

The Swadeshi Jagran Manch (SJM) Delhi Unit Convenor Ashwini Mahajan despite being a supporter of CAS demanded that the implementation of CAS should be delayed till there were enough set top boxes available.

# 1 Sep'03

In Kolkata CAS was deferred as the State Government, seeks more time. I&B Officials say situation would be reviewed after three days.

In Mumbai too CAS is not implemented. MSOs under pressure from the Shiv Sena did not switch off signals.

In Chennai CAS does roll out. But consumer demand for STBs is low. Most viewers watch regional language channels, most of which are free to air.

I&B Ministry called for a meeting with the state officials. Setting up of State level implementation committees comprising of officials from the I&B Ministry, secretary level officers from the states, consumer groups the MSOs and law enforcement agencies.

The CAS issue is being dragged into various courts of the country by various parties. The Madras High Court admitted two public interest litigations challenging the implementation of CAS in Chennai from September 1 .In a complete contrast to the PIL filed in Chennai, the Cable Network Association moved the Delhi High Court seeking implementation of CAS in Delhi from 1<sup>st</sup> September as is being done in other three metros. The Citizen for Just Society, a consumer organization opposing CAS filed a petition in the Bombay High Court asking for a stay on the implementation of CAS.

#### 4 Dec'03

The Delhi High Court after hearing four writ petitions filed by the cable fraternity asking for the nullification of the government notification dated 29th August 2003 that exempted the specified areas in Delhi from the implementation of CAS, Quashed the notification upholding CAS implementation.

#### 15 Dec'03

CAS is implemented in South Delhi by the cable operators/MSOs

#### 19 Dec'03

Siticable, Incable and Wincable start call centers to give CAS Information.

## 26 Dec'03

The Hon'ble Delhi High Court in the Civil Writ Petition number 8993 and 8994 of 2003 in its order dated the 26th December, 2003, declined to restrain the Government from implementing CAS in the National Capital Territory of Delhi and decided to review the situation after three months;

**8 Jan'04** Paramjit Singh Pamma , President of National Akali Dal, demonstrated at Jantar Mantar, New Delhi along with his fellow members in protest against advertisements on pay channels.

## 8 Jan'04

Ms J. Jayalalitha writes to the I & B Minister asking for withdrawal of CAS.

#### 8 Jan'04

MSOs Win cable, Siti Cable, Trinity and IN cable in a press conference declared

that CAS is a success in South Delhi and claimed that 30,000 boxes have been seeded in the market. S.N.Sharma, Jawahar Goel, Anil Malhotra, Arun Mohan addressed the meeting.

## 28 Jan'04

Cable Operators in the presence of Prime Minister of India. Sh Atal Bihari Vajpayee presented the list of facts about the Broadcasters who are proving to be a big threat to their business.

TRAI issues final notification on CAS detailing channel pricing mechanism. Individual pay channel have been priced at Rs 5 each, no intervention in bouquet pricing. Also the notification lists out two standard tariff packages for Set Top Boxes to subscribers in CAS areas.

## 20 Sep'06

The Delhi High Court refused to grant a stay as sought by Star India, on a recent notification issued by TRAI to cap the pricing of pay channels at Rs 5 when CAS rolls out in the country.

### 12 Oct'06

A majority of broadcasters including Star, Zee and Sony have agreed to offer their channels at an MRP of Rs 5 per month under the Conditional Access System (CAS), though some of them have individually challenged the TRAI order on pricing in various courts.

The Delhi High Court refused to grant more time to multi system operators for implementing Conditional Access System (CAS) and asked them to stick to the December 31 deadline for implementing the new system.
